

TERMS OF USE OF COOKIES

Revision dated 03.03.2025

The globalitolympiad.com website and the Internet pages associated with it (hereinafter referred to as the "**Website**") use cookies and similar tracking data collection technologies to identify users of the specified website (hereinafter referred to as "**Users**"). **ALGORITHMIKA LIMITED LIABILITY COMPANY** (PSRN: 5167746505273, TIN: 7704386240, RRC: 770901001) uses these technologies as the Website administrator (hereinafter referred to as the **Administrator**) to ensure trouble-free and continuous access to the Website and the use of the services and products provided:

1. A **cookie** is a small file consisting of letters and numbers that the Website stores on a User's computer or other device when they visit it.
2. The User of the Website agrees to the use of cookies subject to the following conditions:
 - 2.1. if, at the time of visiting the Website, their reception is allowed by the settings/configuration of the User's browser;
 - 2.2. the User continues to use the Website or its services after receiving a pop-up notification about the use of cookies.
3. The User has the right to refuse the use of cookies:
 - 3.1. In the event of the User's refusal, the Website stores only a permanent "regulatory" cookie, which informs the Administrator that the User refuses the use of other cookies.
 - 3.2. To stop processing cookies, the User can change the settings of the Internet browsers used on all devices (electronic computers, mobile devices, etc.).
4. The Website uses the following types of cookies:
 - Technical cookies are files that are necessary for the correct operation of the Website and its specific functions. These cookies are used to identify the hardware and software of the User's computer or other device, to diagnose technical errors in the operation of the Website, and to test new functionality of the Website to improve its performance.
 - Analytical cookies are files that allow to account for the number of Users of the Website, their actions (visited Internet pages of the Website, time and number of times Users view them, etc.). The specified analytics data is collected using Internet services. This information is collected anonymously and is used to compile reports on the number of visitors to the Website, their location, and the Internet pages they visit.
 - Functional cookies are files used to store User preferences (such as preferred language, country, or other online settings) and collect anonymous information on the Website.
 - Advertising cookies are files that help the Administrator analyze from which Internet sources a particular User has accessed the Website. Simultaneously, these cookies make it possible to personalize relevant advertising for the User.
 - Authentication cookies are files that store the necessary User data for accelerated and/or automatic authorization in the Website's registration form.
5. The collection, storage, and processing of cookies are performed by the Administrator in accordance with the **PERSONAL DATA PROTECTION AND PROCESSING POLICY** and the current legislation.
6. The Administrator has the right to unilaterally change the terms of this section, and such changes shall come into effect in 3 (three) calendar days as of the date of publication of the new version of the TERMS OF USE OF COOKIES. Before using the Website, the User undertakes to become familiarized with the new version of the indicated section upon each subsequent visit to the Website. Continued use of the Website will mean that the User agrees to the new version of these Terms in full. If the User does not agree with the new version of the Terms of Use of Cookies, he/she must stop using the Website and its services.

Attention!

If you want to prohibit the Website or third parties from using cookies, you can change the settings of your Internet browser to refuse cookies. Considering that different Internet browsers use different functions of cookie refusal, please refer to the Help menu of your Internet browser and get additional information. Please note that if you refuse the use of cookies by the Website, this may affect the operation of certain functions of the Website, its individual Internet pages or services in general.
